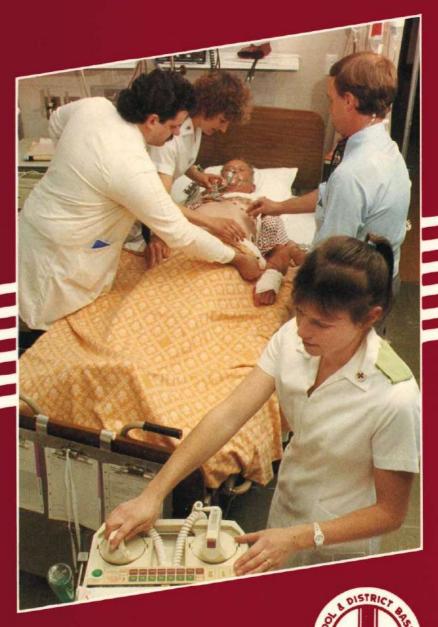

### Functions of the Board of Management:

The functions of the Board of Management of the Warrnambool & District Base Hospital are:

(a) To oversee and manage the Hospital; and

(b) To ensure that the services provided by the Hospital comply with the requirements of the Health Services Act 1988 and the objects of the Hospital.

#### Health Services Act 1988:

The Hospital does not directly administer any Acts. The Health Services Act 1988 was partially proclaimed to take effect on 1st July, 1988, and 14th May, 1989. This Act is the vehicle by which hospitals are incorporated and prescribes the manner in which they are regulated.

#### **Declarations of Pecuniary Interest:**

Where pecuniary interests exist, declarations of pecuniary interest have been obtained from relevant members of the Board of Management and Senior Management staff.

### Setting of Fees:

The Hospital charges fees in accordance with Health Department directives issued under Section 8 of the Hospital and Charities (Fees) Regulations 1986 as amended.

### Requests Lodged under the Freedom Of Information Act:

Eleven (11) requests for information under the Freedom Of Information Act have been received, and these have been dealt with in accordance with the Act.

### On the cover:

The Critical Care Unit provides highly specialised medical and nursing services for seriously ill or injured patients, such as major accident victims, severe burns cases, and some surgical patients following major operations.

65 per cent of Critical Care patients are admitted with heart problems, including heart attack, angina (heart pain), or arrhythmia (erratic heartbeat).

The six-bed Unit is equipped with a sophisticated array of monitoring and resuscitation equipment, to provide intensive nursing care for patients until they have sufficiently recovered to be transferred to other Hospital wards.



### The Year in Review

1988/89 saw the continued development of the Warrnambool & District Base Hospital, with major initiatives and progress being achieved in all facets of the Hospital's operation. The year was also marked by record levels of inpatient and outpatient services.

### Specialist services

Specialist medical and surgical services continued to expand, with specialists in urology, anaesthetics, geriatrics, and psychiatry commencing practice with the Hospital.

### Medical equipment upgrade

A government grant of \$188,700 was received under the Non-Teaching Hospitals Medical Equipment Programme for various capital items of medical and ward equipment, including new lights for two of the Hospital's main operating theatres, and test equipment for the Biomedical Engineering Department.

# Planning for Community Women's Centre

Research in 1988 indicated a need for specialised women's health services of an educative nature, and the establishment of these services became a major goal for the Hospital's Nursing Division.

A Community Women's Centre is being developed, to be fully functional by late 1989. The Centre will offer a range of free information and education services to women of all ages.

# Sub-regional pathology services

Pathology services for southwestern Victoria underwent considerable reorganisation during the year, with the Hospital taking on the role of a subregional pathology service. Three pathologists are now based at Warrnambool to serve all hospitals in the sub-region.

Pathology laboratory workloads increased substantially during the year.

### First stage of Rehabilitation Redevelopment project goes ahead

The first stage of the Hospital's major building redevelopment project was completed at the end of the year, with a newly extended and refurbished ward ready for occupation, and temporary rehabilitation facilities occupied and in use.

### End of an Era in Hospital-based nurse education

The close of Hospital-based nurse training at the Warrnambool & District Base Hospital was marked by three days of events in November, 1988

A day-long seminar entitled 'The Ethics of Accountability, Information, Decision-making, Service delivery' preceded the final graduation ceremony for Hospital nurses.

Attended by more than 600 people, the graduation ceremony highlighted past, present and future nursing roles and ideals.

Other events held to mark the transition to colleged-based nurse training included a Hospital open day, a cabaret ball, a non-denominational church service, and the cutting of a special commemorative cake.

# Radiography intern programme



Miss Rosamund Green became the Hospital's first radiography intern in March 1989, under a new scheme which rotates new radiography graduates through one metropolitan and two regional hospitals during their first postgraduate year.

### Economic impact study

A Hospital-commissioned study of the effects of Warrnambool & District Base Hospital on the Warrnambool economy and community found that the Hospital contributes more than \$13 million annually to the local economy.

The Hospital is the city's major employer, employing 9.3 per cent of the workforce and providing 13.7 per cent of professional employment in Warrnambool. The study concluded that the Hospital has a much wider role in the region than its primary

function of providing health care, and will face increasing pressure to expand as Warrnambool continues to grow.

# Training for fourth year medical students

Training for fourth-year medical students commenced at the Hospital in May 1989, extending the Hospital's involvement in medical training. Groups of students spend five weeks at the Hospital, gaining clinical experience in medical and accident/emergency areas.

### WorkCare bonus

WorkCare claims by the Hospital decreased by 16 per cent in 1987/88, with a 10 per cent bonus being awarded to the Hospital under a WorkCare incentive scheme. Staff education programmes played a major part in reducing work injuries.

### Aboriginal liaison meeting

Warrnambool & District Base Hospital hosted the first country meeting of Victorian Aboriginal Liaison Officers. Attended by Aboriginal Liaison Officers from throughout the state, the two-day inservice meeting discussed a variety of topics, including cancer care, and the role of traditional and modern medicines in aboriginal health.

### Smoke-free policy progress

The Hospital has a firm policy of becoming a 'smoke-free' institution by July 1990, and a staged reduction of smoking areas is well underway.

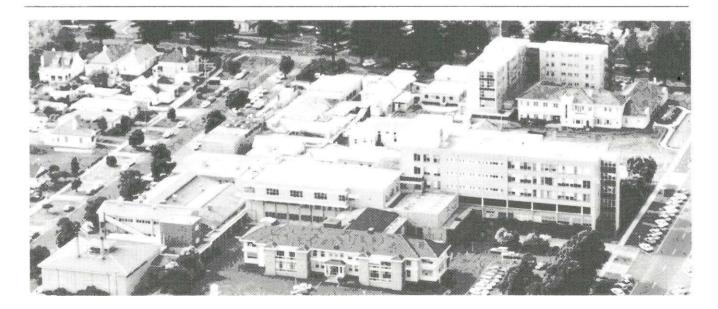
Designated smoking areas are still provided for staff and patients, but visitors are no longer permitted to smoke while in the Hospital.

# Health promotion activities expand

A variety of health promotion activities were undertaken during the year, including displays, newspaper articles and radio interviews on health topics, the production of educational leaflets, and the collection of health promotion literature from various outside sources.

A four-member Health Promotion Co-ordinating Committee has been established to assist Hospital departments engaged in health promotion work.

Committee chairman and Deputy Director of Medical Services Dr Daryl Pedler initiated 'Operation Roadsafe,' a major community road safety campaign scheduled for November 1989, and presently being organised by a committee of representatives from the Hospital, city council, ambulance, police, Roads Corporation, RACV, and local media.



# 135th Annual Report

To the Life Governors and Contributors; Ladies and Gentlemen, on behalf of the Board of Management, I present the 135th Annual Report of the Warrnambool & District Base Hospital, its nursing home annexe Corio House and the Central Linen Service for the year ended 30th June, 1989.

Over the past year the Hospital has continued to develop as a major sub-regional referral centre by expansion and improvement of the services provided.

The continued development of the Hospital has been achieved despite very tight budgetary constraints and financial pressures.

The major highlight of the year was the approval from the Minister for Health to proceed to tender readiness with the \$5.6 million rehabilitation and redevelopment project. Approval for the project which encompasses construction of a paramedical block, medical records department and extension to the Pathology Department has been awaited for many years and planning is now well underway.

Other major highlights of the year are detailed under the Year in Review section of the Annual Report.

### Statistical trends

During the year, the Hospital experienced record levels of patient activity.

The number of inpatients treated continues to grow with an increase of 15.47% experienced during the year. In parallel with this increase is a 10.95% decrease in the average length of stay to a level of 5.04 days.

In addition, the number of total operations increased by 22.9% to a total of 5,750 operations.

The increased inpatient throughput and number of total operations is a reflection on the development of the Hospital as a major sub-regional referral centre and the affect of recently established orthopaedic and urological specialist services. At the same time as the increase in throughput, length of stay has reduced indicating greater demand and utilization of beds and the more efficient use of

Total outpatient attendances increased by 18.9% primarily as a result of increases in attendances at medical outpatient clinics and paramedical departments.

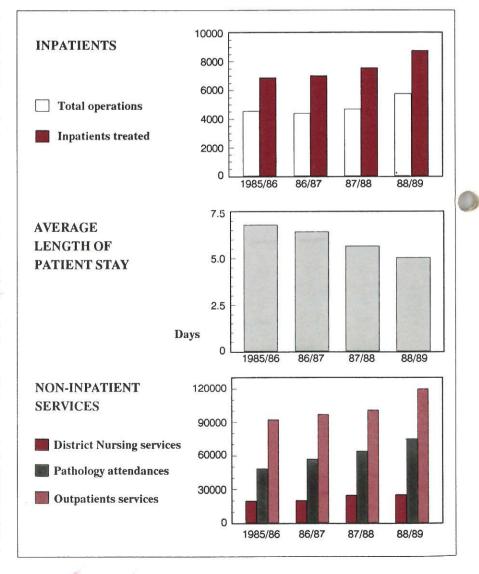
The role of the District Nursing service in providing care to patients in their homes, particularly patients discharged from Hospital, continues to

be of vital importance. This service is particularly important due the need to maintain reduced inpatient length of stay and minimise the number of nursing home type patients occupying acute Hospital beds.

The number of District Nursing service visits increased 2.6% over the very high level established in 1987/88.

The increase in the number of pathology attendances continued with a 17% increase during the year.

The main reasons for the increase were the establishment of a subregional pathology service based at the Warrnambool & District Base Hospital serving Warrnambool, Hamilton and Portland; the closure of a local private pathology laboratory and the additional work generated by the new specialists.



Fully detailed statistical information about patient numbers and Hospital services is listed elsewhere in the Annual Report.

### **Finance**

The Hospital operated under a very tight financial budgetary situation and experienced a deficit of \$196,369 for the 1988/89 financial year. A deficit of \$31,488 was recorded in the accounts of Corio House and a surplus of \$21,943 was recorded for the Central Linen Service.

The major reason for the budget overrun was a substantial 15.47% increase of inpatients treated and the continued high level of public (Medicare) patients, comprising 58% of total patients treated.

The number of inpatients treated in 1987/88 was 7,570 which increased to 8,741 in 1988/89. Consequently, the effect of the increased inpatient throughput was to significantly increase many areas of Hospital expenditure.

Expenditure increases were experienced in payments to Visiting Medical Officers for treatment of public patients, purchases of medical and surgical supplies and provision of pathology services.

The Board of Management and Executive staff met regularly throughout the year with the Regional Director and staff of the Health Department Victoria Regional Office to discuss concerns about the Hospital's financial situation. These discussions were held in a very constructive manner and the support of the Regional Office in attempting to address the Hospital's financial problems has been appreciated.

It should also be noted that the budget deficit of \$196,369 represents

less than one per cent of the Hospital's budget and is indicative of the tight financial control administered by the Finance Committee and Executive staff.

As indicated in last year's Annual Report, self funded public Nursing Homes are experiencing substantial financial difficulties due to the Commonwealth Government not increasing the level of per patient subsidy in line with inflationary factors. As a consequence of this ongoing financial situation, Corio House experienced a deficit of \$31,488 for 1988/89 resulting in an accumulated deficit of \$139,372.

Due to the seriousness of the financial situation of Corio House, many cost containment initiatives were implemented and discussions are ensuing with the Regional Office in an attempt to overcome these financial problems.

In the previous two financial years, the Central Linen Service incurred operating deficits totalling \$109,671. During the period 1986 to 1989, substantial measures were taken to improve the performance of the laundry through a major update of plant and equipment which permitted the release of several staff to transfer to departments within the Hospital as well as allowing others to take early retirement.

During 1988/89, a committee comprising the Acting Chief Executive Officer, Acting Director of Administrative Services, Acting Finance Manager and Central Linen Service Manager reviewed all facets of the operation of the Central Linen Service. As a result a number of ef-

ficiencies and productivity improvements were achieved and the Hospital was able to reduce the general linen rate by one cent per kilogram resulting in savings for all clients of the Central Linen Service.

The review and improvements that have occurred in the Central Linen Service over the past four years have resulted in a surplus of \$21,943 being achieved for 1988/89 and the Hospital is confident that this improvement in profitability will continue.

Fully detailed financial information is contained in the Financial Statements of the Annual Report.

### **Building and Development**

Significant progress has been made on the Hospital's major building projects over the past year.

### Rehabilitation and Redevelopment

On 20th April, 1989, the Hospital was advised through a news release from the Minister for Health, that ap-

proval was given to proceed to tender readiness on the rehabilitation and redevelopment project.

The \$5.6 million project involves three components:

- Construction of a paramedical block to house physiotherapy, occupational therapy, speech pathology, podiatry, audiology, dietetics, social work, medical outpatients and cardiac rehabilitation.
- Extension of the Pathology Department toward Ryot Street. This
  development is needed as the
  Pathology Department is severely
  cramped for space.
- Construction of a Medical Records
   Department near the Accident and
   Emergency Department.

Since the announcement, Hospital user groups have been meeting with the Architects in order to formalise schematic plans and tender documentation. Commencement of construction is subject to further approval and

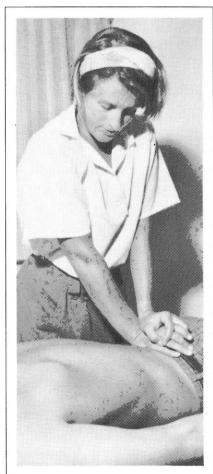
funding by Health Department Victoria.

### Rehabilitation and Assessment Ward — Ward 8

As a preliminary to the major rehabilitation and redevelopment project an extension and renovation of the rehabilitation and assessment ward was completed. The project involved the building of a 12 bed ward joined to the north end of Ward 8. The extension provides two four bed wards, four single bed wards, day room, bathrooms and nurses' station.

The extension increases the capacity of the ward to 27 beds. Upon completion patients housed in the extremely poor conditions of Ward 9 were transferred across.

Health Department Victoria contributed \$300,000 to the cost of the project with the remainder being met from within Hospital resources.

The building was officially opened by The Honourable Caroline Hogg, Minister for Health on 13th July, 1989 and will ensure the very best of facilities for rehabilitation and assessment patients.

the Hospital, so as to provide the best possible facilities for patients and staff.

During the year a total of \$84,879 was raised for the Hospital and Corio House, including bequests of \$13,639.

This ongoing assistance is vital as government funding does not stretch to meet all of the Hospital's requirements. The Hospital is appreciative of the support provided by Auxiliaries, radio station 3YB in the organisation of the annual Hospital Sunday appeal, service clubs particularly the Warrnambool Central Rotary Club in seeking business sector donations, the Red Cross Library and contributors.

The standard of care provided is very much dependant upon being able to retain as well as attract high calibre staff. During the year changes have occurred in key positions in each Division and the Hospital has been fortunate to recruit well-qualified and experienced staff.

Mr David Church was appointed in October 1988 to replace Mr Frank Kelly as Food Services Manager. David was previously Food Services Manager at Echuca District Hospital.

Mr Graeme Mitchell was appointed to the newly created position of Human Resources Manager in May, 1989. The creation of this position being in recognition of the need to strengthen and expand personnel practices, policies and procedures throughout the Hospital.

Mr John Drummond, formerly the Director of Nursing at the Kerang and District Hospital, was appointed to the position of Deputy Director of Nursing in March, 1989.

With the establishment of a subregional pathology service based at the Warrnambool & District Base Hospital, the Hospital successfully recruited two well-qualified Pathologists. Dr Mike Robson commenced in January 1989, and Dr David Blaxland joined the Hospital in April 1989.

Another important appointment has been that of Regional Geriatrician Dr Lukas Hartanto, who, having

emigrated from Sweden, joined the Hospital in April 1989.

It was with regret the Hospital received the resignation of Director of Anaesthetics Dr Geoff Brown, following four years of outstanding service.

In March 1989 the Hospital's Chief Executive Officer, Mr Peter Mc-Gregor, commenced long service leave to undertake full-time study during the 1989 academic year for the Masters of Business Administration Degree. The Hospital wishes Peter every success with his course of study.

Further details of staff changes can be found in Divisional Reports contained within the Annual Report. The Board of Management congratulates all new appointees and thanks staff who have left for their loyal service.

### Industrial relations

The year 1988/89 was relatively stable in terms of industrial relations, with disputation at a very low level.

The only industrial action experienced by the Hospital was on 6th July 1988, when the Hospital Employees Federation took strike action over a 24 hour period in support of a 6% wage increase which was before the National Wage Case.

A total of 852 hours were lost during this industrial action.

### Medical staff

The Board of Management records its appreciation of the professional services of the salaried, sessional and visiting medical staff.

Changes and developments in medical services are detailed in the report of the Director of Medical Services.

### **Board of Management**

The Board of Management has experienced a very difficult and busy year, and I thank all Board members, particularly the chairpersons of the Hospital sub-committees, for their contribution and commitment.

In particular, I wish to draw attention to the outstanding contribution made by Mr Eddie Northeast, who was Treasurer of the Hospital from 1983 to 1988. The responsibility for the Hospital's finances particularly in times of economic restraint and increased patient throughput is an extremely complex and time consuming

task, which has been performed in a very competent and capable manner by Mr Northeast and the Finance Committee.

During the year four positions on the Board of Management were advertised due to the effluxion of time. The four retiring members were Mr S. Carroll, Mr J. Samon, Ms. E. Lindsay and Dr R. Sobey. With the exception of Dr Reg Sobey, the retiring Board members all sought re-election and were subsequently re-appointed. Dr Stuart Smith was appointed to the remaining position.

I wish to acknowledge the outstanding service given by Dr Reg Sobey to the Board of Management. Dr Sobey has been a Visiting Medical Officer to the Hospital for a period of 35 years and during his 25 years on the Board has provided invaluable advice and medical expertise.

The Chairman of the Medical Staff Group continues to attend Board of Management meetings in an advisory capacity. The contribution provided by Dr Noel Bayley in this capacity has been of great assistance to the Board.

### Regional Office – Health Department Victoria

The Board of Management and Executive staff wish to record their appreciation for the support and assistance provided by Regional Director, Mr Brian Butterworth, and the staff of the Regional Office.

The Hospital has been confronted by many complex and difficult issues during the year and the very positive support provided by the Regional Office in attempting to resolve these matters has been appreciated.

### Conclusion

Despite the Hospital operating in a climate of financial constraint and workload pressures, the year 1988/89 was one of substantial progress and continued development.

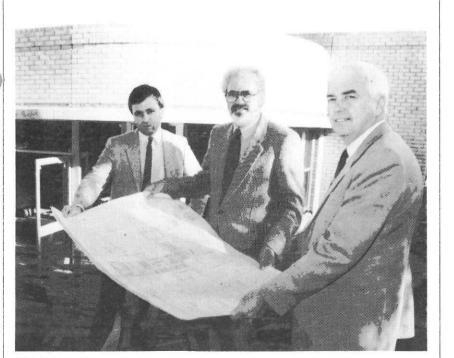

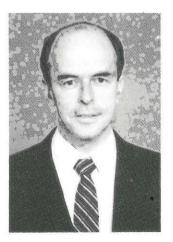

## **Principal Committees**

The Principal Committees of the Board of Management oversee major areas of Hospital management, performance, purchasing and planning. Outlined here are the major purposes of these committees, and the extent to which objectives have been achieved in the year ended 30th June, 1989.

# Joint Committee of Management (Rehabilitation Redevelopment)

### Purpose:

Oversees the Rehabilitation Redevelopment Project and ensures that function, cost and time parameters of the project are adhered to.

#### **Achievement:**

The Rehabilitation Redevelopment Project was maintained on schedule and the functional requirements of users incorporated into the project.

### ■ Patient Care Review & Joint Consultative

### Purpose:

Reports to the Board of Management on the overall quality, effectiveness, appropriateness and use of services rendered to patients in the Hospital.

Conducts reviews of specific aspects of patient care and recommends appropriate action as necessary.

### Achievement:

Maintenance of Accreditation Standards.

### Pharmaceutical Advisory

### Purpose:

Regularly reviews drug therapy in the Hospital with the aim of monitoring drug usage and costs.

### Achievement:

There was no increase in drug expenditure in 1988/89 whilst patients treated increased 15.47% and surgical procedures increased 22.9% over the levels of the past year.

### Multidisciplinary Ethics

### Purpose:

Functions as an advisory body and considers ethical issues as they are referred to it in individual cases.

Makes recommendations to the Board of Management on policy matters concerned with ethical issues relating to the functioning of the Hospital.

Assesses all protocols covering research involving patients and ensures that they and the conduct of the research itself conform to the relevant National Health and Medical Research Council Guidelines.

#### Achievement

Consideration was given to several issues and recommendations were made in respect of research protocols and ethical matters.

### Finance

### Purpose:

Examines financial reports prepared monthly under the direction of the Chief Executive Officer and makes any recommendations to the Board of Management it considers necessary.

### **Achievement:**

Increased productivity as evidenced by a 1.4% reduction in cost per patient treated.

### House & Works

### Purpose:

Monitors the maintenance of hospital grounds, buildings and equipment, and makes recommendations to the Board of Management on major and minor works, equipment, replacements and maintenance.

### Achievement:

Standards of buildings and facilities have been maintained or upgraded as necessary. An active equipment upgrade programme has been pursued and is detailed in the President's Report.

### Staff

### Purpose

Interviews and determines the suitability of applicants for senior management positions and makes recommendations to the Board of Management.

#### **Achievement:**

Recruitment of well qualified senior management staff as evidenced in the lists of executive and senior departmental staff.

### Medical Appointments Advisory

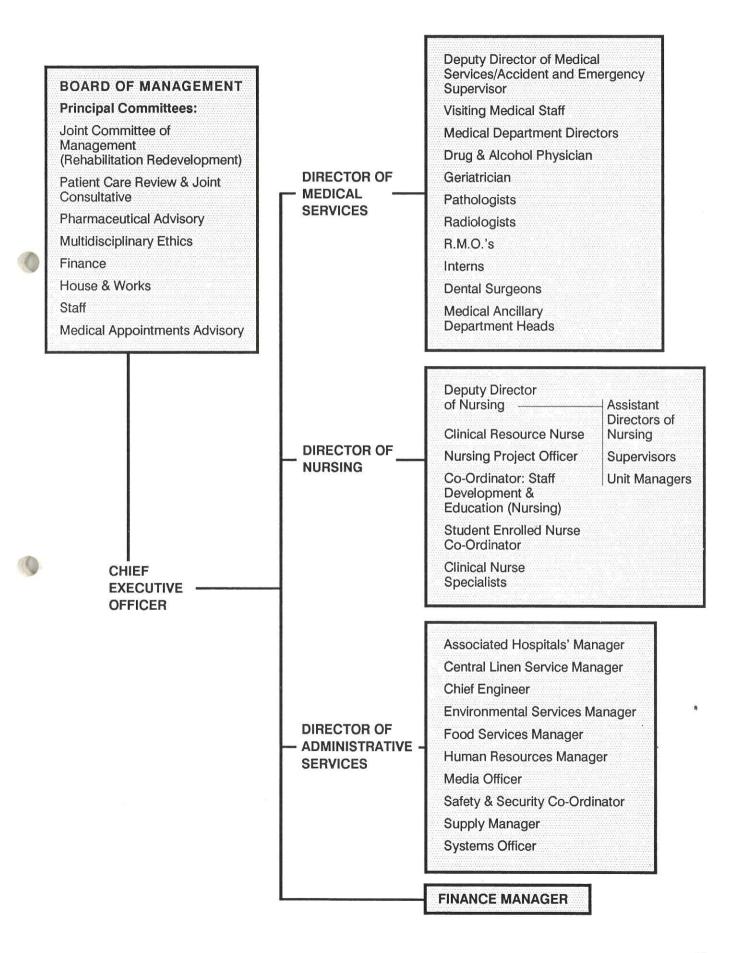
### Purpose:

Advises the Board of Management in accordance with the Hospital By-Laws in respect to the appointment of visiting medical practitioners and dental staff.

### Achievement:

Appointment of a full range of visiting medical practitioners and dentists in accordance with the levels of medical specialisation specified in the Hospital's Role and Function Statement.

### **Future Direction**

The year 1988/89 was one of the busiest in the Hospital's history, and this high level of activity is likely to continue in the following year. Several developments during the year will continue in 1989/90, and will significantly affect the Hospital.

### **Building Works**

The Hospital has in progress a number of building projects which are in various stages of planning. The projects include:

- Rehabilitation redevelopment project which has Health Department Victoria approval to proceed to tender readiness stage.
- Renovation of nurses' stations in Wards 1, 2 and 3 is in the planning stage with tenders to be called in August, 1989.
- Renovation of the Midwifery Ward is in the planning stage with tenders to be called in August, 1989.
- Operating Theatre renovations: a feasibility study is to be undertaken by the Hospital's Architects in regard to overcoming spatial and traffic flow problems.

### **Health Service Agreement**

Discussions have commenced in relation to the Warrnambool & District Base Hospital entering into a 1989/90 Health Service Agreement with Health Department Victoria.

Discussions on the Agreement will include the negotiation of the budget allocation, one year operational plan which outlines priority goals to be achieved during the year, a strategy plan for the next five years and throughput targets.

Throughput targets set for 1988/89 were achieved in all major patient areas. Comparison of Hospital throughput against target figures is detailed below.

### **Bed Blockage**

A problem that is becoming of increasing concern to the Hospital is the blocking of acute beds by nursing home type patients.

With the ageing of the community, and Warrnambool being developed as a retirement centre the number of nursing home beds available within Warrnambool and surrounding district has become inadequate. As a consequence, patients requiring nursing home beds are having to be admitted to the Hospital, and occupy acute beds.

Up to 14 per cent of the Hospital's beds are being occupied by nursing

home type patients, and if current trends continue this is likely to increase even further.

The Hospital has experienced a substantial increase in patients treated, and cancellation of elective surgery is becoming a concern.

In response to the problem, the Hospital has commenced discussions with the Regional Office of Health Department Victoria, City of Warrnambool, Lyndoch Home and Hospital for the Aged and other health care providers in the area.

Considerable attention is being given to this matter as it seriously impacts upon the ability of the Hospital to provide acute health care to the community.

### **Accreditation Survey**

The Hospital's last accreditation survey was conducted in 1986 and resulted in the Hospital being given a full three year accreditation status.

Accreditation is the process by which the quality of care provided by a Hospital is assessed, and compared with the standards of the Australian Council on Healthcare Standards.

Following the last survey an Accreditation Sub-Committee has met regularly to prepare for the survey to be held in March, 1990. Particular attention has been given to addressing the recommendations from the 1986 survey.

### **Medical Services**

The past year has seen a continued expansion of both medical and medical ancillary services to Warrnambool and the surrounding sub-region.

In the area of specialist medical services, the Hospital has seen the arrival of Mr. Brendan Mooney from Ireland as its Urological Surgeon, and the arrival from Sweden of Dr Lukas Hartanto as the Regional Specialist Geriatrician.

Two Specialist Pathologists were recruited during the year: Dr Mike Robson, from Westmeade Hospital in New South Wales, and Dr David Blaxland from Tasmania. Dr Jim Barson joined the staff as a Specialist Anaesthetist, coming from the Austin Hospital in Melbourne, while Dr Mark Ivers, also from Melbourne, joined the Hospital as Specialist Psychiatrist, and an appointment has also been made for a full-time Oto-rhino-laryngologist, who will be resident in Warrnambool and will take up his appointment at the Hospital late in 1989.

These seven new specialists are in addition to other specialists appointed last year. Warrnambool & District Base Hospital can now provide a true sub-regional specialist referral service to the south-west, with an extremely

wide range of specialist medical services available on-site in Warrnambool. This greatly reduces the need for patients to leave the south-west in order to obtain specialist opinions or treatment.

Dr Clare Mooney has commenced duties as a General Practitioner in Warrnambool, and also holds an appointment at the Hospital. In addition to her general practice workload, Clare has assisted the Department of Medical Administration from time to time.

A major event during the last twelve months has been the re-organisation of Specialist Pathology services in the south-west of Victoria, with three specialist pathologists now providing a sub-regional pathology service. Although based in Warrnambool, the pathologists travel to Hamilton Base and Portland and District Hospitals to provide an on-site service at these hospitals.

This new sub-regional service should lead to a more stable and effective Pathology service being delivered to the entire south-west. Having the three pathologists based at the one hospital should not only lead to some continuity of service, but also help remove the professional isolation of the solo specialist in the country. The service has now been running for over six months and to date has been very successful.

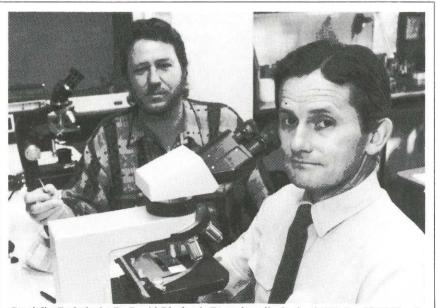
Another success this year was the recruitment of Junior Medical Staff. For the first time in several years the Hospital was able to commence the year with a full complement of Junior Medical Staff. Five Interns now work on rotation from the Geelong Hospital, three Resident Medical Officers are appointed directly by this Hospital, and two other Senior Resident Medical Officers come on rotation from St. Vincent's Hospital in Melbourne. The latter two are trainee Specialists in Internal Medicine and General Surgery.

This recruiting success meant that the Hospital commenced the year fully staffed, and this in turn meant that proper Resident Medical Officer allocations were possible.

Dr Daryl Pedler, Deputy Director of Medical Services, has produced a varied and interesting Education Program for the Junior Medical Staff as well as the Senior Medical Staff. He now produces a fortnightly Education Diary, covering all meetings to be held in that period. An average of five or more meetings per week are held, with a wide range of topics, including: drug and alcohol problems, X-ray sessions, clinical presentation sessions, audits, accident and emergency tutorials, and formal lecture sessions.

In addition, Dr Pedler co-ordinates the quality assurance programmes within the Medical Staff. The Medical Staff is divided into departments, with each department responsible for presenting its own quality assurance activities to the remainder of the Medical Staff on a regular basis.

Cathy Dow, Deputy Chief Medical Records Administrator, was appointed during the year as Quality Assurance Co-ordinator for the Ancillary Medical Services throughout the Hospital. This involves approximately 15 departments and has meant a heavy workload for the Co-ordinator.

Cathy is responsible for co-ordinating the quality assurance programmes of all ancillary medical services and producing a register of their activities.

Cathy also acts in an educative role assisting these departments to produce meaningful quality assurance activities, and to this end has produced an extremely useful guide for the departments to use in their quality assurance work.

The Ancillary Medical Services of the Hospital have also had a busy and demanding year. There have been changes in Departmental Heads in several departments, and also expansion of services in some departments.

Rosina Vickers was appointed as the Hospital's Audiometrist and provides a service to the sub-region.

Bio-medical Engineer Ray Bowles left during the year, and was replaced by Mr Don Stewart from the Epworth Hospital. Demands on the biomedical service were increasing rapidly at the time of Mr Stewart's appointment, and accordingly an Assistant Biomedical Engineer was appointed shortly afterwards.

Sue Baudinette resigned as Chief Dietitian and Thyra Galvin was appointed to that position.

Jody Gibbs was appointed Chief Occupational Therapist and during the year this department has not only expanded in its number of therapists, but has been extensively re-organised to provide a wide range of services to this Hospital and to many other district hospitals. Jody Gibbs was overseas on a study tour of the United States, United Kingdom, and Bangladesh earlier in the year, and Kate Lhuede, one of her Therapists, will be leaving for an exchange programme in Canada in early 1990, with a Canadian therapist coming to Warrnamboool to work as her replacement.

The Podiatry Department has also expanded from two to four podiatrists during the year; despite this there is still a heavy workload on the Department. Conditions in the department did, however, improve during the year with a move to new premises.

Susan Tuohy resigned as the Hospital's Social Worker and has been replaced by Marie Farley, from Adelaide. In Speech Pathology, Chris Harvey resigned and Janet Bayne was appointed as Chief Speech Pathologist.

In addition to the many changes in Departmental Heads the Ancillary Medical Services have been busy this year, not only in expanding their clinical services throughout the subregion, but also in planning for a new paramedical block to be built at the Hospital.

This building will allow the integration of the many services available at this Hospital and will provide new and exciting premises for the highly developed services we provide. The Ancillary Medical Services have had to become closely involved with the architects and the Hospital Executive in planning the new building, and although much work has already been put in by these Departmental Heads, there is still a great deal of work to be done.

A loss to the Hospital this year was the resignation of Dr Geoff Brown from his position as Specialist Anaesthetist and Director of Anaesthetics. During his time here Dr Brown was an excellent Director of Anaesthetics and worked extremely hard at developing the Anaesthetic Department and raising its standards.

In both of these areas he was extremely successful, and he will be much missed by the Hospital.

In May this year, the Hospital began to receive fourth year medical students from the Medical School of St. Vincent's Hospital in Melbourne, which is part of the University of Melbourne Medical School. The Hospital had already been receiving medical students for accident and emergency electives, country electives, and paediatric electives, but this meant that the Hospital would now also receive medical students early in their training.

This has proved to be an exciting development in the Hospital and has been welcomed by all members of the Hospital staff. It also means that both medical students and junior medical staff are present in the Hospital at various stages of their training, and it is hoped that this will result in Melbourne medical students becoming more aware of the Warrnambool & District Base Hospital and that this will in turn aid recruitment in years to come.

It can be seen, therefore, that 1988-89 has been an exciting year for the Medical Division. Expansion of Medical and Ancillary Medical Services, combined with the introduction of new Specialist services and Medical Student education, has produced an air of excitement and a sense of purpose throughout the Division.

I would like to take this opportunity to thank the many members of the Medical Staff and the Ancillary Medical Staff who have assisted me during this busy year within the Division. Without their support, advice, and assistance, it would not be possible to introduce new services and to expand current services.

I would also like to thank members of the Executive for their support during this time, as any expansion in the Medical Division must obviously have effects in the other two Divisions. The support of members of the other two divisions has been very much appreciated during the last twelve months.

I look forward to next year when it is hoped we can consolidate our subregional role for this Hospital.

The prime objective for the year was to focus on Women's Health Issues and we have been successful in being able to achieve this objective in meeting the expressed health needs of women in the community.

### End of an Era

In November 1988, to mark the completion of General Nurse Training at this Hospital, a number of activities were arranged.

The most spectacular occasion was the 49th Nurses' Graduation Ceremony held on the 4th November, 1988. Over 600 people attended and witnessed 37 Registered Nurses and 21 State Enrolled Nurses receive their Hospital certificates.

Gillian Biscoe, Consultant, Human Resource:Management and Organisational Change, New Zealand Department of Health, was the guest speaker. Gillian delivered a stimulating address entitled 'People, Potential and Nurses'.

The Gold Medal and Vivian Balmer Prize was awarded to Brian Gorman. The Award of a Gold Medal has traditionally been the highest award offered to a nurse at graduation, it is interesting to note that in the last year that this coveted prize was awarded, the recipient for the first time was a male nurse.

# Community Women's Centre

As Director of Nursing, I not only have a commitment to standards of patient care in the Hospital itself, but a responsibility to meet the expressed needs of the community.

This year our project was the establishment of a Community Women's Centre, which will operate from 11 Hider Street, Warrnambool. The services that will be provided for women by women from this centre will include:-

- Continuation of existing services provided for women by the Warrnambool & District Base Hospital.
- Health Education Programmes.

Co-ordinated by Mrs Caroline Silver, Registered Nurse, these activities will be administered by a Steering Committee under the auspices of the Board of Management of the Warrnambool & District Base Hospital. The Steering Committee will comprise representatives from the community and health care disciplines.

Ms D. Clanchy has accepted the appointment as the Board of Management representative on this Committee.

I would like to extend my sincere appreciation to Mrs Karen McKinnon (Acting Nursing Projects Officer) and Mrs Caroline Silver who have researched and planned to ensure this project will be implemented to meet all needs.

### **Ethics and Nursing**

Ms Megan-Jane Johnstone, a leading Nurse Ethicist and Lecturer in Nursing, was the keynote speaker at a major two day seminar conducted on the 23rd and 24th February, 1989.

Ms Johnstone, who has recently completed a Masters majoring in Philosophy and Ethics, proved a most knowledgeable, credible and popular speaker.

Megan addressed those ethical issues that are of great significance to the professional nurse who is increasingly having to wrestle with those

dilemmas involving quality versus quantity of life decisions, patient's rights, informed consent and advocacy.

At the invitation of the Association of Directors of Nursing (Victoria), I arranged a Twilight Seminar for members and senior staff on Friday, 24th February, 1989 at the Warrnambool Institute of Advanced Education.

The theme for the evening was 'Ethics', with guest speaker Ms Megan-Jane Johnstone, Lecturer in Nursing, Phillip Institute, and Ms Barbara Piesse, Lecturer in Law, Warrnambool Institute of Advanced Education.

### **Review of District Nursing**

The Royal District Nursing Service (Melbourne) agreed to undertake a review of the District Nursing Service at this Hospital on the 27th and 28th February, 1989.

Mrs Beverly Armstrong, Regional Supervisor, Royal District Nursing Service, was appointed as the Surveyor. Mrs Armstrong made a number of recommendations which we are in the process of reviewing and implementing.

### The Cancer Care Programme

The Warrnambool Cancer Care Programme started in 1984 with the formation of a professional group, the Cancer Support Team, and the training of eight members of the community as volunteer workers.

In 1986, with the aid of donations from the community, the Palliative Care Unit was established for cancer patients who require hospitalisation.

The past twelve months have seen a large expansion in the service offered and in the utilisation of same. In 1988 there were 50 admissions to the Palliative Care Unit involving 34 patients and their families.

The nursing team, led by Elizabeth Southcombe, follow-up bereaved families and also visit and support cancer patients admitted to other wards.

Each Friday morning in the lounge room of the Unit, Dr Eric Fairbank conducts an educational session to help patients and their families understand and cope with cancer.

The sponsorship money from the Mildura to Moyne Bike Ride this year has been used to educate twelve new volunteers, bringing the total number of volunteers to 28. This has enabled this service to extend out of the city of Warrnambool and into the surrounding districts.

A Regional Palliative Care Team has been established this year. Mabel Mitchell, the Co-ordinator of the Cancer Care Programme and Dr Eric Fairbank have been appointed to the team to assist in the establishment of palliative care services in the southwest sub-region. They will conduct education programmes for nursing and medical personnel, as well as providing support and act as resource persons for those working in this field.

The future plans of the Warrnambool Cancer Care Programme will focus on providing assistance, thus enabling patients to remain at home as long as possible. This support will include a twenty four hour on-call availability of the District Nursing Service.

### Recruitment

Our nursing staff establishment numbers have been maintained to a large extent through the Continuing Education Programmes we conduct for nursing staff. It is also pleasing that we are able to recruit Registered Nurses with specialist qualifications in areas such as paediatrics, critical care, midwifery and oncology.

### Appreciation

Mrs Doreen Risby, Co-ordinator for the 'Arts for the Children' Council presented to Mrs S. Morrison (Unit Manager) and myself a tapestry wall hanging on 9th November, 1988.

Depicting a child's view of the 'Warrnambool Hospital by the Sea' the tapestry was embroidered by ap-

## **Administrative Services**

Administrative Services Departments introduced increased efficiencies this year, finishing under budget with all major goals achieved.

### **Engineering Services**

The year 1988/89 saw a continuation of a pattern set in previous years with works undertaken falling into three broad categories:

Minor Works projects are projects specifically funded by Health Department Victoria, costing up to \$50,000. In 1988/89 these projects have included a new heating system in the Rehabilitation and Assessment Ward, new emergency battery supplies for the Hospital and extensive renovations to the General and Administrative Offices.

Capital Works undertaken included the installation of a new high pre-vacuum steriliser in the Central Sterile Supply Department.

Normal routine maintenance covers a wide variety of tasks, some taking only seconds and some extending over several months. The larger tasks included extensive renovations to the Assessment and Rehabilitation Ward, the installation of portable buildings for use by paramedical staff, and the installation of new natural gas pipelines.

We are still working actively to improve our gardens and grounds and are beginning to see some definite results.

### Associated Hospitals' Manager

Mr Peter Eldridge resigned from the position of Associated Hospitals' Manager on 1st February, 1989 and has been replaced by Mr Trevor Mc-Kenzie who transferred from the position of Office Manager in the General Office of the Hospital.

Associated hospitals and institutions administered by Warrnambool and District Base Hospital are:

- The Mortlake District Hospital;
- Timboon and District Hospital:

• Timboon and District Community Health Centre;

Corio House.

The major achievement for the year was the opening of a refurbished Accident and Emergency Department at The Mortlake District Hospital. Total cost of the project was \$90,000.

The Mortlake District Hospital has received funding for the appointment of one additional District Nurse plus the cost of a motor vehicle to service the growing proportion of aged persons in the community.

# Safety & Security Department

The objective of return to work programmes – to bring injured workers back into the work force, and to encourage development in alternate skills, has been implemented successfully throughout the year.

This success can be seen when new work injury claims resulted in only ap-

proximately 4,000 lost hours, as opposed to approximately 12,000 lost hours in the previous year.

Various educational programmes were introduced, increasing staff awareness, knowledge and education in prevention of work injuries. These programmes include back care, manual handling, correct use of equipment and hazard identification.

During the year, Safety & Security Officer Mrs Sue Watt travelled to Beijing, China, to gather information at the International Conference on Ergonomics, Occupational Safety, Health and the Environment. Her paper 'Prevention of Back Injuries to Nurses' was well received with research data and other material being sought by participants both within and outside Australia. The information obtained by Mrs Watt has been of significant benefit to the Hospital.

The Department's work focuses on the safety of patients and staff in the Hospital. Education, awareness and elimination of hazards are paramount in achieving a safe and secure environment for all staff members and patients.

### **Systems Department**

The first stage of the Pharmacy program was successfully installed onto the ICL System 25 by the end of April, 1989. Facilities provided by this stage of the program are production of prescription labels, work value statistics, daily registration of patients, monthly patient register, and monthly invoicing of regional hospitals for drugs supplied.

The system is particularly useful in providing a patient profile of pharmacy items issued. Further modules to be developed in the coming year are stock control and inventory, and imprest issues of pharmacy items.

An Olivetti 386 processor was installed in the Supply Department for the purpose of networking some of the personal computers within the Hospital. At present there are four monitors and printers connected to the network providing multi-user access to the supply system.

Next year the payroll system will be transferred from the Micromation System to the network, and to enhance the payroll system it is planned to add the following modules of software:

- PERKS (Payroll Enquiry and Record Keeping System);
- ELMS (Employee Leave Management System);
- STARS (Staff Allocation and Rostering System).

Personal computers were installed in the Rehabilitation Unit, Safety and Security Department and Medical Records Department.

A program was developed for Medical Records to provide patient labels and record patient statistics for the Health Services Agreement.

### Human Resources Department

The position of Human Resources Manager was created during the year in response to a growing need for a specialist in industrial and employee relations and personnel functions.

Mr Graeme Mitchell was appointed to the position and commenced on 15th May, 1989.

As a result of this appointment, payroll and human resources have now been integrated into one department and a number of new programs have been initiated including:

- Payroll audit and quality assurance activities planned and partly implemented;
- Introduction of revised procedures for the recruitment and selection of staff;
- Introduction of a Staff Development Review process to be trialled, evaluated and adopted.

As part of the establishment of the Department, major goals to be pursued in 1989/90 are:

- Establishment of an effective and professional human resources/payroll function;
- Implementation of a Hospital-wide orientation and induction programme for new staff;

- Updating of Pay Office role and function, job descriptions and procedures;
- Introduction of exit interviews;
- Expansion of the existing structured industrial relations program;
- Preparation of a Hospital Human Resources Policy and Procedures Manual.

### Supply Department

Supply Department developments during the year were:

- Implementation of the new computer system "Novell Netware" which has provided multi-user access to the Supply Department;
- Non-perishable goods required by the Food Services Department are now issued by the Supply Department;
- Centralization of the ordering and stock control system for the Pathology Department.

Over the past year the Supply Manager has been involved in the review of the Program of Aids for Disabled Persons (PADP) as the Co-ordinator for this region. This culminated in the review document being released by Community Services of Victoria, and is now in the hands of the Minister for Health and Minister for Community Services Victoria.

# **Environmental Services Department**

The Environmental Services Department has completed a successful twelve months. The purpose of the Environmental Services Department is to maintain a high standard of cleanliness throughout the Hospital. Some of the duties performed through the year included preparation of the portable units set up for Rehabilitation paramedical staff, and the new offices in the Accident and Emergency Department.

The most recent project was the preparation of the Rehabilitation and Assessment Ward for occupancy. This was a mammoth cleaning project, and was completed by the Department's staff under Mr. Ken Anderton's supervision.

During the year the Environmental Services Manual was revised, and four quality assurance programmes were put into effect.

### **Food Services Department**

Mr David Church commenced as Food Services Manager in October 1988, following the resignation in July of Mr Frank Kelly, after 19 years of service.

The Food Services departmental role is not only to feed the patient, but also to help educate people to follow a balanced diet each day. Achievement of this policy requires a close working relationship with the Dietetics Department to achieve a common goal: improved health of the patient.

One of the first objectives set for the Department was to revise recipes and choices on the menus in accordance with the guidelines set down by the National Heart Foundation of Australia.

The transfer of storage for bulk food products to the Supply Department has resulted in a more efficient purchasing programme and already is proving to be effective. Although the choice of brand and the source of supply remain with the Food Service Department, the assistance of staff in

Supply has been invaluable in remaining within budgetary restraints.

The year has been extremely busy relative to meal production. This past year we produced 423,606 meals including 53,813 meals on wheels. The increase in output of meals was 3.7% over the previous year.

### **Central Linen Service**

Developments within the Central Linen Service in the last twelve months have centred on cost-efficiency.

A good financial result has been achieved, with a surplus of \$21,943 for the year, allowing a reduction in the linen price. An offshoot of this has been the approach by Cobden & District Bush Nursing Hospital to request our services to commence from 1st October, 1989.

An imprest linen system was introduced into the Hospital during the year and has proven to be very successful. The results have been more efficient use of our linen, as well as the optimum utilisation of staff within the area.

Linen handling between the Central Linen Service and the Warrnambool & District Base Hospital has been dramatically improved.

### Media Unit

The Media Unit (previously the Audiovisual/Publicity Department) was relocated to the first floor of the Villiers Block during 1988, providing improved office space and better access to all technical work areas.

As part of a Workcare Rehabilitation project initiated by the Hospital, Mrs Hellen McLean now works as part-time assistant in the Unit, providing considerable assistance with many projects.

High-quality and cost-efficient desktop publishing of a range of publications has become fully established, and new still photography services and working methods have been introduced.

Publicity work included general Hospital publicity and various health

promotion topics for feature articles and interviews. Requests for medical teaching aids are increasing, as medical training at the Hospital expands.

### Corio House

Corio House Staff have found the year to be rather difficult, due to financial restraints. However, Director of Nursing Jessie Johnson and her staff have continued to place emphasis on the family home concept for Corio residents.

Important aspects of Corio House such as the garden, informal entrance and the lounge layouts, help to prevent an institutional setting. Family and friends are encouraged to be involved in the care and life of their family member.

The staff at Corio strive to ensure that all residents are treated as individuals, treated with dignity and respect, and receive the highest quality of care.

Corio House continues to experience an upward trend in the dependency rate of residents. The majority of the people admitted for care are usually immobile, incontinent, with a multiplicity of impaired faculties.

Corio staff are currently preparing for accreditation, ensuring that the standards as outlined by the Australian Council on Healthcare Standards are met.

Jessie Johnson has requested that I convey her personal thanks to all staff at Corio House for their continuous support and assistance.

The liaison with other departments of the Warrnambool and District Base Hospital is very gratifying, and their assistance is appreciated. Staff also acknowledge the continued contribution made by clergy, auxiliaries and school groups and look forward to continually promoting the highest standard of patient care for the aged.

### Appreciation

I thank all of the Heads of Departments and their support staff for the efficient and co-operative manner in which they have carried out their duties, and I refer particularly to cost reductions achieved whilst maintaining standards of care for an increasing number of patients treated.

# **Fund Raising**

Fund raising events and donations are important sources of revenue for many equipment purchases. This year, a total of \$84,879 was raised for the Hospital and Corio House.

# **Support from** interested community groups

A successful year of fundraising culminated in the 3YB Annual Appeal on Sunday, 18th June, 1989. Radio station 3YB again donated a full days broadcasting to the Appeal plus considerable lead up publicity.

A highlight of the day's activities was the Great Southwest Bedpush. A combined Base Hospital/Brierly Hospital team won by one kilometre from Koroit Hospital, with Mortlake in third place. The winning prizemoney of \$300 (donated by 3YB) was split between Warrnambool & District Base Hospital and Brierly Hospital.

On the weekend of April 22nd and 23rd the gruelling annual 24 hour Mildura to Moyne Cycling Marathon was conducted. This event raised \$3,500 for the Palliative Care Unit Education Fund.

Four Hospital teams joined more than 180 other riders to tackle the challenging 520 kilometre relay.

A new addition to our list of fund raising teams this year was the Warrnambool Central Rotary Club, which generated \$3,000 by conducting a door knock of business houses. The S.E.N. Past Trainees Association disbanded in February, 1989, but in so doing cleared their bank balance of \$2,488 for the benefit of the Education Centre. We are grateful also for the support of the Past Trainees Association.

### Hospital auxiliaries

All Hospital auxiliaries have reported successful fundraising and social activities this year.

As well as the Combined Auxiliaries Fete in June, the auxiliaries conduct separate events during the course of the year.

The Staff Auxiliary raised \$24,000 with a variety of fundraising events, including an innovative charity golf day which may become an annual event. The auxiliary's donation is being put towards a new fire escape for the operating theatre and new equipment for district nursing, operating theatre, radiology and Accident/Emergency.

The main fundraising events for the **Junior Ladies Auxiliary** are the Christmas stall and Christmas luncheon, with theatre and card luncheons also being popular.

Hospital's Catering Department is greatly appreciated by the auxiliary. The members maintain a keen interest in the Hospital, and raised \$7,200 over the past year.

Formed in 1923, the Senior Ladies

Formed in 1923, the Senior Ladies Auxiliary provides a valuable sewing service to the Hospital, and this year, with the help of several new members, repaired over 1100 linen articles. Auxiliary member Mrs Mona Hayes received a Life Governorship for her work in the Auxiliary over many years.

The auxiliary raised \$550, which will help purchase wheelchairs and a new washing machine for the Rehabilitation and Assessment Ward.

The Hospital's nursing home annexe Corio House continues to benefit from the efforts of its own auxiliary. With support from all staff at Corio House, cake stalls, raffles, and sale of produce raised \$1,664. The money will be used to purchase a microwave oven for Corio's kitchen, and a 'Whipper Snipper' for the garden.

Last year, the 30 member Woolsthorpe Auxiliary donated money for an Imed pump, and this year raised \$2,000 for Hospital equipment. Successful events included a film luncheon, raffle, morning coffee party, and catering for two functions.

A small but committed group of seven members, the Nullawarre, Mepunga & Nirranda Auxiliary conducts a doorknock collection and raffle during June, to coincide with the 3YB Appeal. This year a good response from all districts raised \$1,867, over \$400 higher than last year's total.

### **Direct donations**

During the year the Hospital received direct donations from individuals and philanthropic trusts totalling \$45,000.

Donations of \$10.00 and over are listed elsewhere in this Annual Report. These donations are evidence of the strength of community support for the Hospital.

### The Education Centre

A major change of focus in educational activities has been gathering pace at Warrnambool and District Base Hospital over recent years. This change is reflected in the multidisciplinary use of the Education Centre, in contrast to the singular role traditionally exercised by the School of Nursing.

Early records are vague, but it appears that nurse training began at the Hospital around the turn of the century, with training for the Royal Victorian Trained Nurses Association examinations being well established by 1916.

The subsequent progression of years has witnessed a parade of young men and women participating in the long and proud history of nursing education at this Hospital. Over 1000 of these young people have graduated into the world of Registered Nurses, while more than 500 others have participated in the training programme for Nursing Aides (Enrolled Nurses) which commenced in 1961.

Enrolled Nurse Training continues to be an important facet of education at the Hospital, but 1988 marked the final stage in the phasing out of the Hospital-based education programme for general nurses. The ties have not been completely severed, however, as the Hospital provides part of the clinical component of the Diploma in Nursing programme conducted by the Faculty of Nursing and Health Sciences at the Warrnambool Institute of Advanced Education (WIAE).

Little is documented about the classroom facilities available for nurse training in the very early days.

The building that is now the Villiers Block housed classrooms during the 1940's, but it was not until 1953 that a formal training facility was opened in the Nurses Home (now Heytesbury House) with the establishment of the John Hunter Henderson Memorial Lecture Room.

It is interesting to note in the Annual Reports of this period mention being made for the first time of education outside the realms of nurse training.

However, the principal focus continued to be that of nurse training, and in 1963 a new School of Nursing with all modern facilities was incorporated into the mezzanine floor of the Hospital's multi-storey building.

These facilities were further enhanced by the development of library facilities, and the subsequent opening in 1980 of the John Reid Library.

With changes to nursing education on the horizon, work began in conjunction with WIAE to study the practicalities of college-based nursing education in Warrnambool. In the same period, the school began developing post-registration nursing courses, as a means of enhancing patient care by providing continuing education to staff from this and other district hospitals.

The initial courses developed for continuing education included:

- A First Year Graduate course, to assist the transition from student to registered nurse. Allied to this, a preceptorship or 'buddy' scheme was implemented, to help reduce personal and professional isolation for new staff.
- A refresher course for general nurses.
- A Midwifery Update Program for midwives practising in small rural hospitals, providing them with the opportunity to enhance prior learning.
- Short courses in creative management for nurses.

Following the state Minister for Health's announcement that a preregistration nursing course would commence at the WIAE in 1986, a phasing out programme was commenced at the Hospital.

This enabled the facilities of the Education Centre to be used by other Hospital departments for a variety of educational purposes – the mezzanine floor was rapidly becoming a primary education and information resource for the entire Hospital.

With meeting room space becoming increasingly scarce in the Hospital, the Education Centre also became the venue for several regular meeting groups and committees.

Some of these committee meetings, such as those for Nursing Administration, Administrative Services, Computer Services, Medical Directors, Surgeons, Infection Control, Clinical Liaison, Staff Development, and Rehabilitation Redevelopment, are presently more administrative in nature rather than educative.

Others, however, have either a direct educational role, or are involved in the organisation of educational activities. The quarterly Library Committee meeting, for example, reviews book and video purchase recommendations, and discusses the various issues relating to the use of information throughout the Hospital.

Occupational health and safety has a high priority at Warrnambool & District Base Hospital; an ongoing education programme for all staff involved in patient handling uses the practical room facilities of the centre as the venue for safe lifting demonstrations and correct patient transfer techniques.

Other meetings and staff briefings are also held in the Centre, including First Aid classes. The Hospital's Cancer Support Team, which is composed partly of volunteers, meet in the Education Centre for introductory and ongoing education.

The Centre also provides a forum for the Cancer Self Help Group to discuss common problems and to share ideas.

Some community and professional groups also use the Centre as a meeting venue at various times, including local ambulance officers, who conduct training courses on subjects such as cardiac monitoring and defibrillation; lip reading classes; and Brierly Hospital and WIAE nursing student tutorials.

The development of the postgraduate nursing education programme had a secondary aim – that of assisting in nurse recruitment.

The changeover to college-based nurse education has meant that the Hospital competes with other hospitals for new graduates as well as for more senior staff. This has provided the impetus for a more entrepreneurial approach to the marketing of the Hospital's nursing facilities, including a heavy emphasis on continuing education.

Thus, considerable postgraduate nurse education takes place in the centre. Study days continue to be held regularly for both registered and enrolled nurses, with a wide and varied range of topics. Such has been the success of these, that attendees are drawn from throughout south west Victoria and eastern South Australia.

Coronary care workshops for critical care staff help maintain awareness of patient symptoms, and of the correct operation of the highly sophisticated monitoring and life support systems in use at the Hospital.

With bio-medical equipment now widely used in all patient care areas, study days on the proper use of infusion and syringe pumps are an important means of maintaining staff knowledge.

The study days are often used to demonstrate new equipment, or potential equipment purchases, allowing discussion and comparison of operating ease and system functions.

Many other departments and groups use the centre on an irregular basis. For some, it is a convenient place to view videotape, films or slides, as one room is set aside for audiovisual usage. Others make use of the considerable flexibility in seating and table arrangements to configure rooms to their own short-term requirements.

This multidisciplinary use of the centre is certain to increase in coming years. The recent establishment of a Human Resources Department, increased medical student education, and continued expansion of the educational component of the Hospital's occupational health and safety programme, point to future uses of the Education Centre for the education of staff from all Hospital departments.

The Education Centre will play an important and continuing role in assisting the Hospital to meet its health education and information objectives.

# Patient Numbers by Locality

The State of Victoria is divided into eight health regions and the Warrnambool and District Base Hospital is sited in Region 1, the Barwon and Southwestern Region.

The Warrnambool and District Base Hospital acts as the sub-regional referral centre for this region. The Hospital's recruitment of specialist medical services enhances this role.

During the year, the Warrnambool and District Base Hospital admitted a total of 8,741 inpatients. Of this number, 96% were drawn from within Region 1 and a total of 4% were drawn from other regions and interstate.

# Notes To and Forming Part Of the Financial Statements for the Year Ended 30th June, 1989

### NOTE 1: STATEMENT OF ACCOUNTING POLICIES

The financial statements of the hospital have been prepared in accordance with the provisions of the Annual Reporting Act 1983 and the Annual Reporting (Contributed Income Sector) Regulations 1988.

The Accounting Standards issued jointly by the Institute of Chartered Accountants in Australia and the Australian Society of Accountants have been complied with where applicable.

#### 1. Accrual basis

In accordance with the Regulations, the accrual basis of accounting has been used with revenues and expenses recognised as they are incurred, and brought to account in the period to which they relate, except as mentioned herein.

#### 2. Historical Cost

The financial statements have been prepared on a historical cost basis whereby assets are recorded at cost and do not take into account changing money values nor the current cost of non-current assets (unless specifically stated).

### 3. Rounding Off

All amounts shown in the financial statements are expressed to the nearest dollar.

### 4. Investments

Investments are valued at cost. Interest revenue from investments is brought to account as it is received.

### 5. Depreciation

Fixed assets of the Hospital with value in excess of \$1,000 are brought to account and depreciation has been provided over their estimated useful lives using the straight-line method.

The following accounting policies represent a departure from Australian Accounting Standards AAS4, Depreciation on Non-Current Assets, which states that fixed assets are to be depreciated over their estimated useful life. The effect of this departure on the accounts has not been calculated.

- i) Depreciation is provided for Linen Service Plant and Equipment and is recorded as an expense in the Revenue and Expense Statement. This amount is credited direct to the General Reserve to provide funds for asset replacement and is not recorded as provision for depreciation.
- ii) No depreciation has been provided for Nursing Home Plant and Equipment as no asset register existed.
- iii) At balance date no independent valuation had been received on Land and Buildings and as the value of buildings is not available, no depreciation has been charged on this asset.

#### 6. Stores

Inventories are stated in the Balance Sheet at the lower of cost and net realizable value. Cost is determined principally by the first-in, first-out method.

### 7. Employee entitlements

### Long Service Leave

Provision for long service leave is made on a pro-rata basis for all employees who have completed five or more years service for the Central Linen Service only. The Hospital and Nursing Home provision for long service leave is made for all employees upon completion of 10 years service when the entitlement becomes payable. The proportion of long service leave estimated to be payable within the next financial year is included in the Balance Sheet under Current Liabilities. The balance of the provision is included under Non-Current Liabilities.

### Annual Leave

A provision for annual leave is made for all employees based on the hospital's accrued liability for annual leave at 30 June 1989. This provision is included under current liabilities.

### Accrued Days Off

A provision is made for accrued days not yet taken but accrued by eligible employees.

### 8. Superannuation

All eligible employees contribute to the Hospitals Superannuation Fund established under section 10 of the Hospital Superannuation Act 1965 (refer Regulation 32).

As a result of the 3% Productivity National Award decision all employees from 1 July 1988 automatically became entitled to the Basic Benefit Superannuation package. The Hospital contributes 3% of salaries of each employee to the Hospital Superannuation Board on a monthly basis.

The hospital also offers membership to the employees in the Hospital Superannuation Board contributory scheme which provides the option of a pension/lump sum combination or wholly lump sum benefit and a choice of death and disability covers.

The following two contributory scheme options are available:

- a) Employee Contribution 3% and Hospital Contribution 5.5%
- b) Employee Contribution 6% and Hospital Contribution 11.5% based on the ordinary salary of the employee.

Under the Annual Reporting (Contributed Income Sector) Regulations 1988, a hospital is not required to disclose in the balance sheet non-current assets held prior to 1 January 1989. However, this is a departure from Australian Accounting Standard AAS6, Accounting Policies: Determination, Application and Disclosure. As the hospital accepts substantially all of the risks and benefits incidental to the ownership of the Crown land, it is my opinion that the asset should have been valued and recorded in the balance sheet.

Under the Annual Reporting (Contributed Income Sector) Regulations 1988, a hospital is not required to provide depreciation on non-current assets held prior to 1 January 1989. Consequently, the hospital has not provided for depreciation on the non-current assets relating to the Nursing Home and all buildings. This is a departure from Australian Accounting Standard AAS4 Depreciation of Non-Current Assets. In my opinion, depreciation, which allocates the cost of an asset over its useful life, should have been provided on these items and been included as an operating expense in the revenue and expense statement.

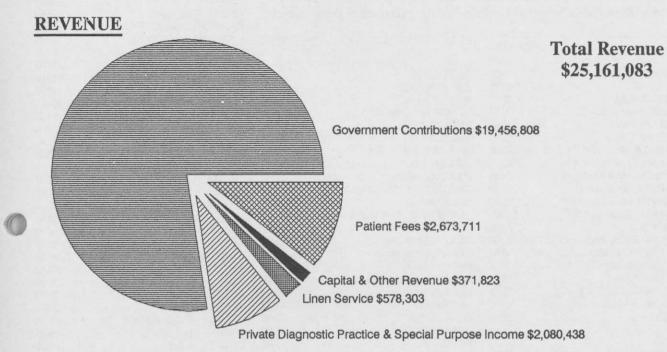
The hospital did not maintain a complete asset register to support the items of plant and equipment totalling \$4.7 million in the balance sheet. As the hospital did not have an adequate record to enable audit verification of these items in the balance sheet against the assets on hand, I am unable to determine the cost or existence of all the assets making up the items in the balance sheet, the adequacy of the depreciation charge on these assets for the year and the accumulated depreciation at year end.

In my opinion, the financial statements comply, in all material respects, with the requirements of the *Annual Reporting Act* 1983 and except for the effect on the financial statements of the matters referred to above, present fairly the state of the affairs of the Warrnambool and District Base Hospital as at 30 June 1989 and the results of its operations for the year ended on that date in accordance with Australian Accounting Standards.

# Revenue & Expenses Graphs for the Year Ended 30th June, 1989



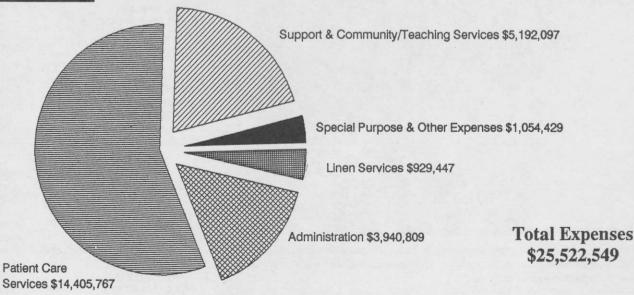
These graphs summarise the combined total Revenue and Expenses for the Hospital, Nursing Home and Central Linen Service for 1988/89, using an accrual basis as detailed on page 39 of this Financial Report.

Government Contributions represented 77% of total revenue for the year; Patient Fees contributed 11%, Private Diagnostic Practice and Special Purpose income 8%, Linen Service income 2%, with Capital and Other revenue also contributing 2%. The total revenue of

\$25,161,083 was an increase of 16.5% over the previous financial year.

Patient Care Services represented 56% of total expenses for the year. Support, Community and Teaching expenses formed 20% of the total, Administration expenses 15%, Linen Service costs 4%, with Special Purpose and Other expenses making up the remaining 5%. Total expenses rose 12% over those of the 1987/88 financial year.

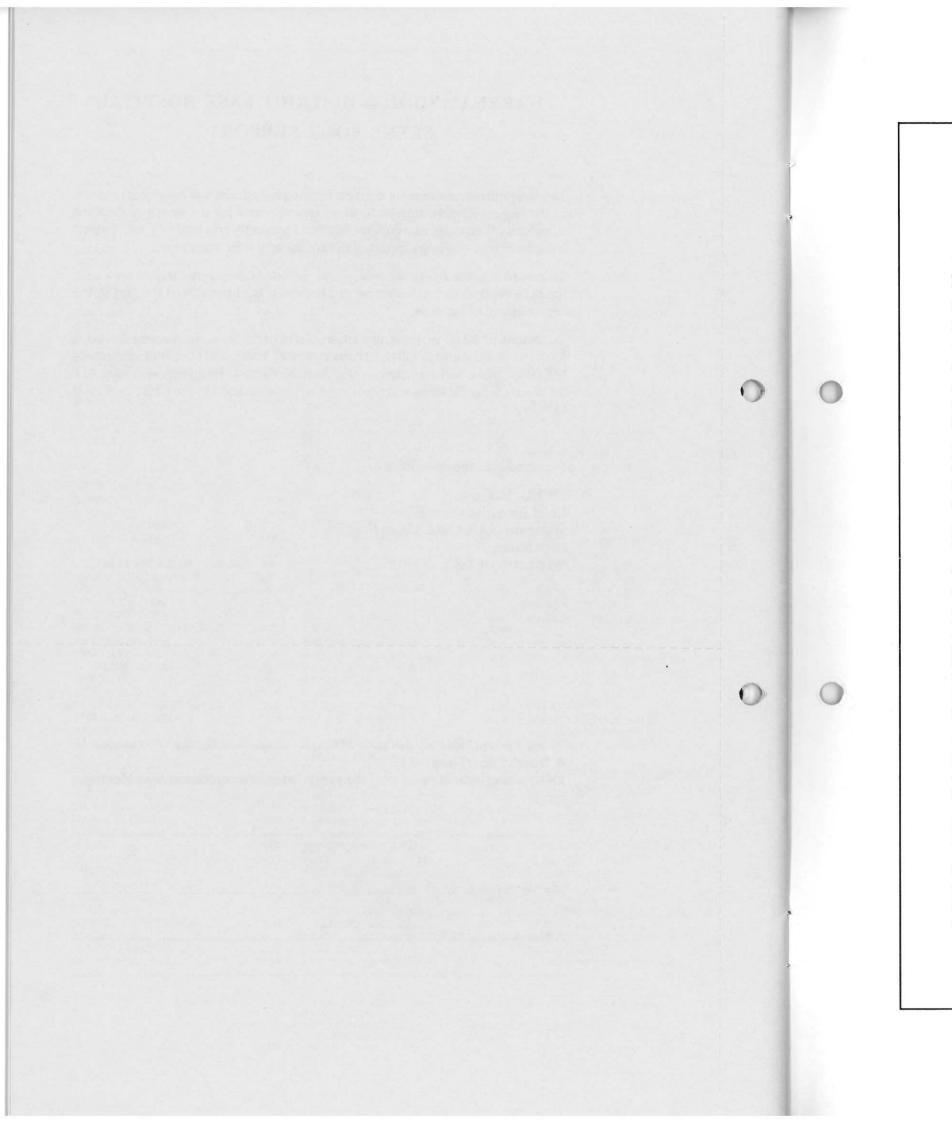

### **HISTORY**

The Warrnambool and District Base Hospital has been in operation 135 years.

Originally the Hospital was established to provide care to the sick and needy, and was titled the Villiers & Heytesbury Hospital and Benevolent Asylum.

The Hospital has been located on the present location since 1861, with the site having been acquired in 1853. Prior to the first building being commissioned on the present site in 1861, the Hospital operated from 1854 to 1861 in rented premises on the corner of Koroit and Henna Streets.

In 1901 discussions commenced over a proposal to establish a midwifery section. It was not until 1928 that a maternity ward was constructed. Prior to 1928 babies were delivered by qualified nursing sisters in private homes or in private hospitals run by local doctors.

In 1914 the number of medical and surgical patients exceeded the benevolent daily average for the first time. In 1925 the Hospital's role changed completely to the provision of medical and surgical services.

The Hospital has undertaken a number of building and rebuilding programmes.

In 1938 construction of a 60 bed wing to accommodate private, intermediate and midwifery patients was completed. This wing was named the Marcus Saltau House, in recognition of the Honourable Marcus Saltau, President of the Hospital from 1904-1905 and 1912-1941, and a member of the Board of Management from 1899 to 1941.

In 1961 planning commenced for the construction of a multi-storey block to provide accommodation for wards, diagnostic departments, paramedical departments, outpatient clinics, Nursing and Nursing Aide training schools, general store, Matron's office and reception.

In 1963 the multi-storey building was opened by the Honourable R.W. Mack MLC, Minister of Health.

Since at least 1940 the Hospital has had Base Hospital status and in recent years the role of the Hospital as a sub-regional referral centre has been developed. The Hospital now provides an extensive range of general and specialist services.
